

Terms and Conditions:

The following are the terms and conditions of the agreement under which room/s are permitted to be used by guests and binding on them.

1. Nothing herein shall be deemed to constitute the relation of landlord and tenant between the management of the B & B and any visitor guest. The management shall always be deemed to be in possession and control of the whole of the B & B premises.
2. The management reserves to itself the right to add, to amend and/or alter any of the terms, conditions and/or rules at any time whatsoever without assigning any reason.
3. The management reserves to itself the right of inspecting any or all of the rooms occupied by the guests.
4. The management reserved to itself the right to ask any guest to vacate his or her room/s at any moment without prior notice or without assigning any reason whatsoever.
5. The tariff card and menu is provided in the rooms, please check and ask accordingly.
6. The payment/booking amount must be paid in cash/demand draft and in Indian Rupee only.
7. Pets are not allowed.
8. Check in time 12 noon/Check out time 12 noon.
9. The management does not hold itself responsible for the loss of or damage to guests, goods or any property, due to acts of god, the republic's enemies, war, insurrection, civil commotion, fire, earthquake, etc.. Safe deposit is provided in the dressing room.
10. Luggage keeping facilities is available, but for maximum period of 7 days, beyond 7 days Rs. 100.00 per day/per luggage will be charged, for a maximum period of 30 days from date of booked, beyond 30 days or no turn up to collect the same, the owner/manager has full rights to dispose the same.
11. Guest's will be held responsible for any damage caused to any of the B&B property movable or immovable either themselves, their visitors or by their attendants.
12. Storing of cinema films, raw and exposed or any other articles of combustible or hazardous nature, is strictly prohibited.
13. The management is not held responsible for power cut by supplier.
14. No Services of Prostitution or any unlawful activities are allowed in the accommodation and if found guilty then local law will be enforced.
15. Rights of the accommodation and entrance reserved.
16. Guests shall disclose his correct particulars for making entries in the register maintained by the owner;
17. Guests shall not allow any other person to stay in the establishment overnight.
